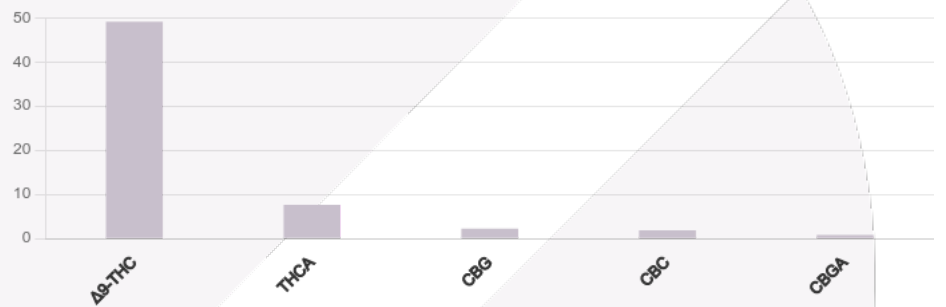
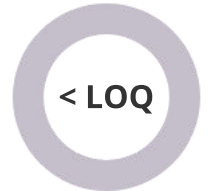
TOTAL CANNABINOIDS



TOTAL THC

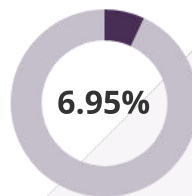

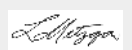
