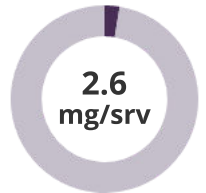
TOTAL CANNABINOIDS



TOTAL THC

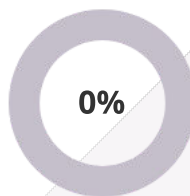
