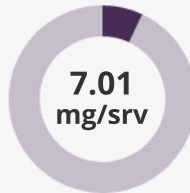

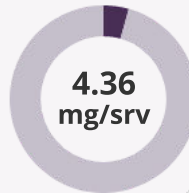

TOTAL THC

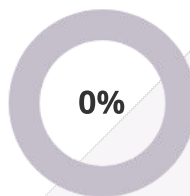
