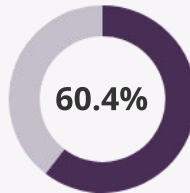

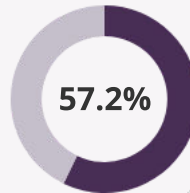

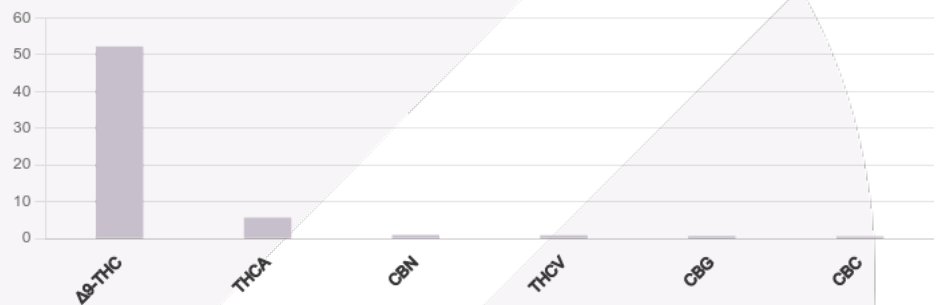
TOTAL CANNABINOIDS

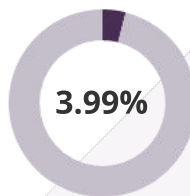
