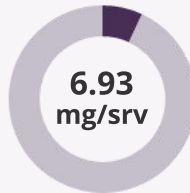

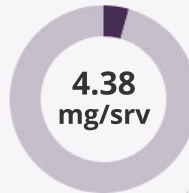

TOTAL THC

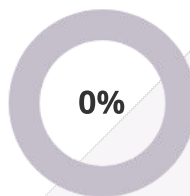
