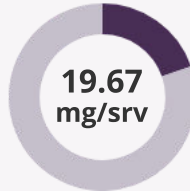

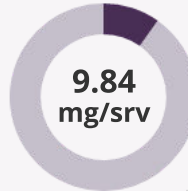

**TOTAL THC**

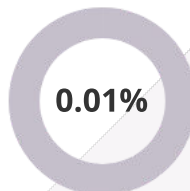

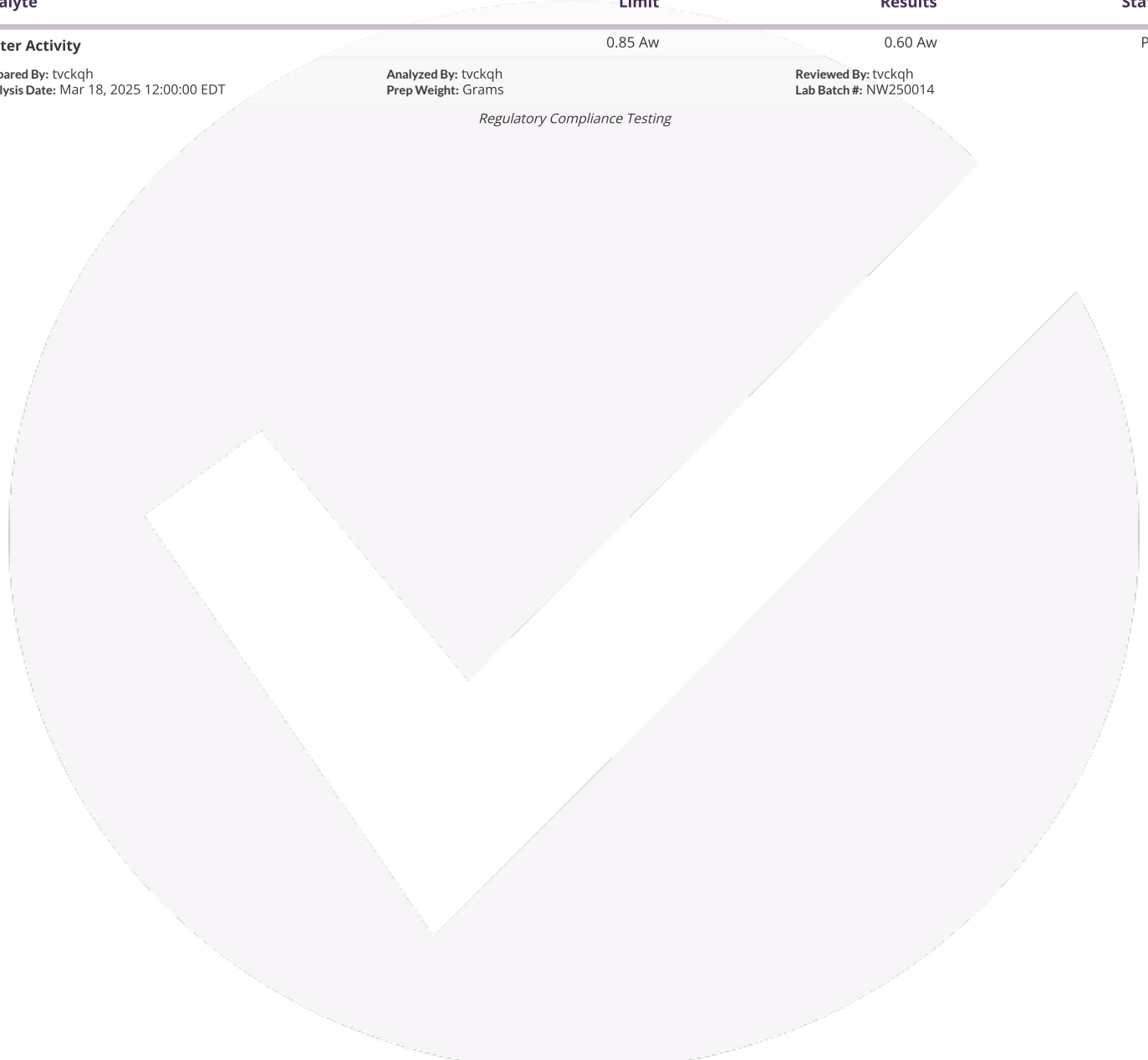
