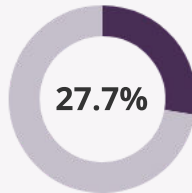

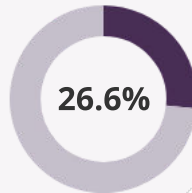

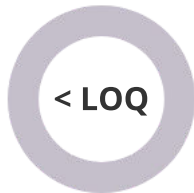
TOTAL CANNABINOIDS

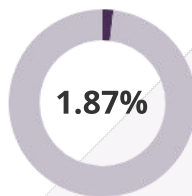
