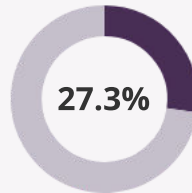

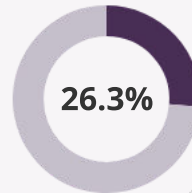

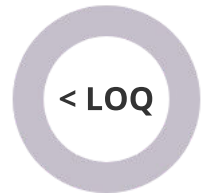
TOTAL CANNABINOIDS



TOTAL THC

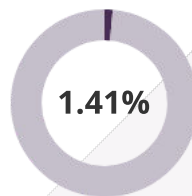
